RULES AND REGULATIONS

PLEASE NOTE: THERE ARE NO PUBLIC TOILETS

1. Exhibitors are solely responsible for any loss, injury and/or damage to any person, animal, or Property occasioned by, or arising from, any person or equine exhibited, and shall indemnify the Organiser and landowners against all and any legal, or other proceedings, which may arise there from.
2. The judges' decision is **FINAL**.
3. Any discourteous behaviour towards the judges, stewards, helpers, etc. will result in dismissal from the showground and entries will not be refunded.
4. No entry fees will be refunded due to classes clashing.
5. The Organiser reserves the right to refuse entry, amend judges, without giving a reason.
6. No horse or pony under 4 years old may be ridden in any class or on the showground.
7. **No Dogs** are permitted on the showground.
8. All riders must wear a correctly fitted and current standard riding hat at all times.
9. Stallions under 13.2hh may NOT be led by any person under 12 years old.
10. Stallions over 13.2hh MUST be led by persons 14 years and over.
11. All litter is to be taken home.
12. Absolutely **no mucking** out of lorries or trailers on the showground.
13. There will be **NO PUBLIC TOILETS AVAILABLE**.
14. You must return to your vehicle with your horse/pony after your class.
15. Please stay by your lorry/trailer as much as possible.
16. You **MUST** keep 2 meters between you and any other horse or pony in hand and ridden that did not come to the show with you in your vehicle, at all times whilst on the showground.
17. For everyone's safety, anyone whilst in the showrings that does not, or cannot, maintain this 2 meter distance **WILL** be asked to leave.
18. **EACH** Child under the age of 14 must be accompanied by an adult who is solely responsible for them at all times while on the showground. You will be asked to leave the showground, and forfeit all entry fees, for failure to comply in **ALL** circumstances.
19. Body protectors are recommended for jumping competitors.

This show will be subject to social distancing, both in the show rings and the show ground at all times. You **MUST** obey all instructions given to you by the judges, stewards and parking attendants. Failure to do so may result you being asked to leave the ring, and possibly the show ground.

Anyone who has COVID-19 symptoms or has been in contact with anyone who has COVID-19 or COVID-19 symptoms **MUST NOT ATTEND.**

Everyone attending the show must wash or sanitise their hands regularly. Facilities to do so will be provided near the secretaries' tent. The wearing of face masks is optional.
